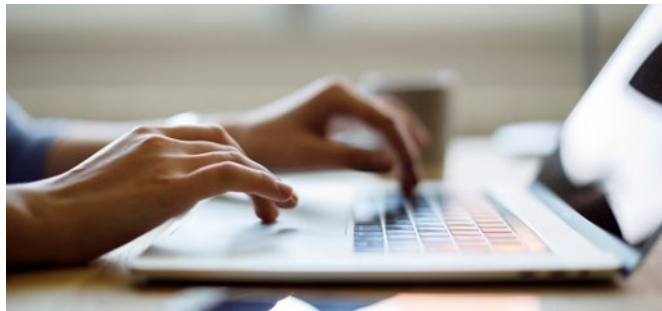
Your organisational integrity is an asset, a measurement of values alignment and, increasingly, a bottom-line requirement.

HOW CAN OSACO'S ORGANISATIONAL INTEGRITY SUPPORT HELP YOUR ORGANISATION?

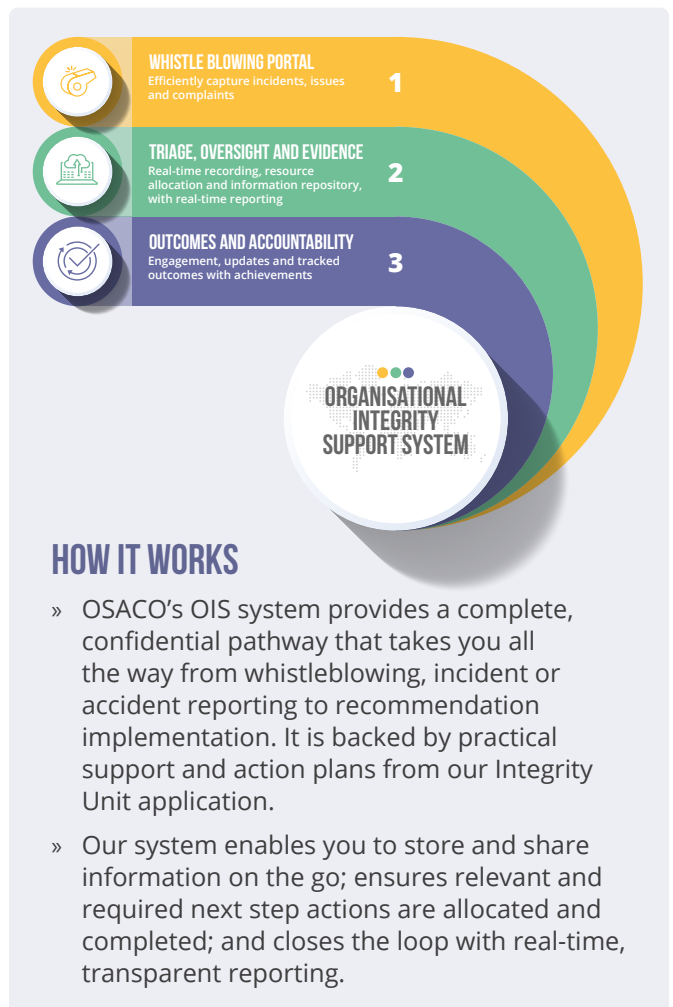

WHISTLEBLOWING PORTAL

- This allows you to efficiently capture incidents, issues and complaints of all kinds.

MANAGEMENT TRIAGE, OVERSIGHT AND EVIDENCE REPOSITORY

Real-time recording

- Clearly record actions related to the incident.
- Lodge summary notes at each stage of the incident process.
- Enables easy communication between the manager and the assigned member.

Resource allocation

- The system identifies resources required and assigns people to the tasks at hand.
- The manager inputs resource allocation.
- Ability to identify the need for additional or specialist resource.

Central, secure and mobile information repository

- Centralised, secure and mobile (cloud-based).
- All material is lodged in the online system, making it is accessible anytime, anywhere.

Real-time reporting access

- See the incident status and obtain a summary as and when required.

- Regular engagement and updates from team members and managers are required by the system.
- Tracks outcomes achieved against recommendations.
